## Peer Support Specialist, Adult Addictions, Application Fall 2025

#### **Course Overview:**

This is a 40-hour, 5-week course approved by the Oregon Health Authority (OHA). The Peer Support Specialist, Adult Addictions program will prepare participants to deliver services in behavioral health settings to promote recovery and resiliency. It will prepare students for work as an entry-level Peer Support Specialist. It addresses all competencies required for approval as a Peer Support Specialist training program in Oregon. The course will be offered as a hybrid model combining face to face instruction with synchronous and asynchronous online instruction. As required by the Oregon Health Authority students will also complete an Oral Health Training (OAR 410-180-0365 Oral Health Training Requirements) that will be embedded into the course.

A peer support specialist for adult addictions shall be: (a) A self-identified individual currently or formerly receiving addictions; (b) A self-identified individual in recovery from an addiction disorder who meets the abstinence requirements for recovering staff in alcohol or other drug treatment programs.

• Adult Addictions: A person in addiction recovery who provides support services to people seeking recovery from addiction.

Successful completion qualifies individuals to apply for certification through the Oregon Health Authority to become a Peer Support Specialist. Completion of the course is one of the requirements to become a Peer Support Specialist, the following additional requirements have been put into place by the Oregon Health Authority. All of which must be completed to become certified.

## Oregon Health Authority requirements for certification:

- Completion of an OHA approved PSS course
- Must be at least 18 years old
- Must complete a criminal background check (OAR 410-180-0326 Background Check Requirements)
- Must have a Government Issued Id (state ID, driver's license, or passport)
- Certification renewal; every 3 years must complete 20 hours of continuing education. (OAR 410-180-0320 Traditional Health Worker Continuing Education Requirements)

This is a limited enrollment course, students are accepted on a first come, first serve basis and must meet all application requirements. We will be accepting 15 students per cohort.

#### **Course Cost:**

Total Program Cost: \$450 (approximate)

- Program cost \$400
- Participants will be responsible for a \$50 fee associated with the criminal background check.
   (OAR 410-180-0326 Background Check Requirements) \* The price of the background check may vary.
- Note: Course tuition or fees are not refundable beyond the first week of class. Additional course fees may be applicable and are non-refundable
- Account balances must be paid within 10 business days or have a payment plan set up with Business Services to avoid late fees or removal from the program.

#### **Course Schedule:**

This is a 5-week, 40-hour program. Classes will meet on Saturdays from 8PM- 5PM (with a 1-hour lunch) at the Chemeketa Community College Salem Campus. The class Schedule dates are as follows:

2<sup>nd</sup> class: November 8, 2025

3<sup>rd</sup> class: November 15, 2025

4<sup>th</sup> class: November 22, 2025

5<sup>th</sup> class:November 29, 2025

Students must attend all classes to complete the program.

## **Getting Started:**

## **Selection Process:**

The first applicants for each session who meet all the requirements and who have submitted all requested documents will be considered.

## **Criminal Background Check:**

Instructions on how to complete a background check will be provided with an applicant's acceptance notification. Applicants who are on a waiting list will only receive this information upon acceptance from the waiting list.

## **Background Check**

Background checks will be ordered once the acceptance form is turned in. Once you receive the email regarding background checks from Advanced Reporting you will have 7 days to complete the background check from that date. Failure to complete the background check or a background check revealing a disqualifying criminal history will mean you are ineligible to participate in the PSS course.
